

ORDINANCE No. 60/2024
of the Rector of the University of Wrocław
of 26 March 2024

amending Ordinance No. 67/2021 of the Rector of the University of Wrocław
on the introduction of procedures at the University of Wrocław for the recognition
of a diploma of study abroad as equivalent to a corresponding Polish diploma and
professional title and confirmation of the completion of studies at a specified level

Pursuant to Article 23, sections 1 and 2 in conjunction with Article 327 of the Act of 20 July 2018 – Law on higher education and science (Journal of Laws of 2023, item 742, as amended) and the Ordinance of the Minister of Science and Higher Education of 28 September 2018 on the nostrification of diplomas of completion of studies abroad and the confirmation of completion of studies at a specific level (Journal of Laws of 2018, item 1881), it is ordered as follows:

§ 1. In Ordinance No. 67/2021 of the Rector of the University of Wrocław of 18 May 2021 on the introduction at the University of Wrocław of the procedures for recognising a diploma of graduation from studies abroad as equivalent to the corresponding Polish diploma and professional title and confirming the completion of studies at a specified level in § 11 section 1 is replaced by the following:

1) § 11, section 1 shall be read as follows:

“1. A fee of PLN 4,685 shall be charged for the conduct of proceedings in the cases referred to in § 1 section 1.”;

- 2)** Appendix No. 3 to the Procedure is replaced by the wording set forth in Appendix No. 1 of this Ordinance;
- 3)** Appendix No. 4 to the Procedure is replaced by the wording set forth in Appendix No. 2 of this Ordinance;
- 4)** Appendix No. 6 to the Procedure is replaced by the wording set forth in Appendix No. 3 of this Ordinance;
- 5)** Appendix No. 7 to the Procedure is replaced by the wording set forth in Appendix No. 4 of this Ordinance;
- 6)** Appendix No. 8 to the Procedure is replaced by the wording set forth in Appendix No. 5 of this Ordinance;
- 7)** Appendix No. 10 to the Procedure is replaced by the wording set forth in Appendix No. 6 of this Ordinance;

§ 2. Supervision of the implementation Ordinance is entrusted to the Vice-Rector for Teaching.

§ 3. 1. The ordinance shall enter into force on the date of its signature, subject to section 2.

2. The existing regulations shall apply to nostrification proceedings and proceedings for confirmation of graduation from a degree program at a specific level initiated before the entry into force of this Ordinance.
